Information for the invited expert

Our initiative was established 7 days after the war started. The core challenge was to connect teachers and their students through live online sessions based either in Europe or Ukraine. Firstly, we had to address that problem through emergency remote education, designed and delivered via online learning platform and the team of dedicated Ukrainian teachers and coordinators. Its goal is simple: as soon as possible and under any circumstances, connect teachers, students, and classmates, thus, securing a safe and friendly learning environment for them.

Our activities include the regular school year and additional educational and guided leisure Activities and Summer School.

Purpose of the Call

We are seeking qualified external evaluators to ensure independent monitoring and evaluation of the Schooltogo project. The evaluators' task will be to provide objective feedback, identify the project's strengths and weaknesses, and contribute to its optimization.

Specific Tasks for External Evaluator

- Ongoing and final evaluation of project activities according to the indicators in the logical framework
- Prepare the specific evaluation procedures and collection of data.
- Conduct independent external evaluation exercises of the achieved results
- Providing necessary documents and information for the monitoring and evaluation purposes to the EC
- Produce individual evaluation reports, including the final values of the logical framework indicators (report will be sent to the European Commission along with the project's final narrative report)
- Produce recommendations based on report findings and present findings and recommendations
- Evaluate suggested enhancement measures and follow-up plans
- Attend digital meetings

Areas of expertise needed:

- Demonstrable experience in evaluating and/or quality checks of EU-funded projects, particularly in the field of education
- Fluent knowledge of English; knowledge of Ukrainian is an asset (work of the SchoolToGo is carried out mostly in Ukrainian language)
- Communication and Analytical Skills: Ability to communicate effectively, analyze complex data, and prepare clear reports

Total estimated budget for external evaluator: max. 3000 EUR

A specific contract will be set up between SchoolToGo and selected evaluator.
